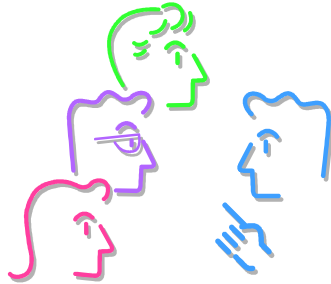

Powerful Progress

Annual General Meeting kicks off Positive Power's Second Year

On Saturday, November 29th, the doors opened at 9:00 a.m. at the Hamilton Incubator of Technology for Positive Power Co-Operative's (PPC) 2003 Annual General Meeting. Copies of the by-laws, the 6-month report on PPC's Flamborough-based Wind Resource Assessment, and audited financial statements were available for review before the meeting start time of 10:00.



The event was an excellent opportunity for current members to renew annual memberships, and, with past and new Board Members, Committee Chairs and the Project Coordinator available to answer questions, to introduce new members to Positive Power.

Ted McMeekin, MPP for Ancaster-Dundas-Flamborough-Aldershot and a long-time supporter of Positive Power, provided welcoming comments to the membership and some information on the new Liberal government's plans with regard to electricity generation policies. He was followed by Positive Power's treasurer, Don Brown, who gave the financial report, with Adam Bolzan from BDO Dunwoody on hand to assist with questions. The financial audit showed that PPC is in a very good position to undertake all of its planned programs and BDO Dunwoody was reelected to audit the records for the coming year.

The meeting offered a time for reflection and recognition of progress made to date, as Positive Power thanked the Hamilton Grant Review Team of the Ontario Trillium Foundation for their funding grant. The \$150,000 two year grant will allow PPC to educate the community, explore options for using wind power as a renewable energy source, and initiate the community co-operative model for renewable energy projects. Both Ken Hall and Susan West were on hand as Trillium Foundation representatives. Ms. West noted that the grant to Positive Power was their largest grant awarded in this area, and she commended the group for their accomplishments to date. Martin Ince of MK Ince and Associates provided a detailed report on the Wind Resource Assessment Report based on the first six months of testing at the Hamilton's Drumlin. Wind speeds look encouraging, and the assessment is moving forward as expected.

Melinda Zytaruk, Community Services Manager, brought greetings from the Ontario Sustainable Energy Association, and provided an overview of current issues and future directions for the community

power movement in Ontario. She indicated that Positive Power is a leader in the community renewable energy co-operative sector that other emerging groups look to for process and guidance as they build organizations in their own communities.

Business was underway by 11:00, with presentations from Positive Power Corporation officers on activities from the past year and upcoming initiatives. Jon Norman, the current chair of the Board, also took the time to thank past members of the Board who have moved on to other commitments: Martin Ince, Pam Wilkie, James Murphy, and Brent McKnight.

The feasibility study for the co-operative revealed several options for the co-op to become sustainable without core funding from the government or foundations. These options include increasing the membership base, project-based revenue, and participating in a "green tags" program.

By-Laws are a Changin'



Change is required from time to time, and all the changes that had been proposed to the Co-op's bylaws were passed at the Annual General Meeting.

Members voted to amend the by-laws, bringing all of the suggested changes into effect.

1. The membership can now vote to remove a member from the co-operative through a simple majority vote instead of the 75% required previously.
2. Bylaw 9, regarding membership meeting location specifications, was removed in accordance with the Ontario Co-operatives Act.
3. By-law 12 was amended to eliminate voting by proxy at Co-op general meetings.
4. The number of Directors required to be at membership meetings has been increased to 40% instead of 25% with an amendment to by-law 14.
5. A change to by-law 17 specifies how many Directors must be present at Board meeting to carry out business (3/5 or 7/12).
6. The creation of an executive committee has been limited to cases where there are more that six directors through a change to by-law 34.
7. By-law 50 now indicates that the membership's ability to appoint an auditor for the coming year requires a meeting with more than 59 co-op members in attendance.

Feasibility Study Complete

A report on the recently completed feasibility study was presented at the AGM. The study presented options for the co-op to become sustainable without core-funding from the government or charitable foundations. A final version is being examined and discussed by the board, and a more complete report on the results will be available for circulation some time in the new year.

Hoovers Point Town Hall draws Crowd

A crowd of approximately 50 attended a Town Hall meeting held by Positive Power at the Rainham Centre Community Centre on November 4, 2003. Positive Power conducted a brief presentation highlighting the benefits of renewable and wind energy, and the opportunities for rural landowners in areas of excellent wind resources. The presentation was followed by a question and answer period lasting approximately one and a half hours. The enthusiastic crowd was well informed, and interested in the possibilities of developing wind resources in the Selkirk/Hoovers Point area. The purpose of the Town Hall meeting was to address both the opportunities and impacts of wind resource development for landowners in the area.



Positive Power board member and presenter, Jon Norman stated, "I am happy with the turnout, it is good to see landowners in the area taking an active concern in how their energy is provided, and seeking information on the benefits and details of wind resource development."

The Hoovers Point/Selkirk area is a proposed location for a second Wind Resource Assessment by Positive Power. Both before and since the Town Hall meeting the technical committee has been in contact with landowners in the area in the hopes of reaching an agreement for the erection of an anemometer for a Wind Resource Assessment with the hopes of eventually erecting a wind turbine in the area. .
